- 1. All entrants must be members of the GREATER LAKE COUNTY USBC BOWLING ASSOCIATION and at least 50 years of age. If a bowler does not reside in our LAKE COUNTY boundaries, that bowler must have at least a 12-game current average in a Greater Lake County Association League. If not a member of the Greater Lake County Association, entrant must pay a certification fee of \$10.00.
- 2. Entrants in this tournament shall use their HIGHEST USBC CERTIFIED FINAL AVERAGE from the 2017-2018 season (minimum of 21 games). If there is no final average from 2017-2018, entrants shall use their HIGHEST USBC CERTIFIED AVERAGE for 12 games or more as of October 27, 2018, in which case a league standing sheet must be provided to the tournament director. All others will bowl scratch.
- 3. Format for the tournament is an 8-pin no-tap with handicap. Three games will be bowled. Handicap for bowlers age 69 and under will be based on 90% of 210. Handicap for bowlers age 70 and over will be based on 100% of 210.
- This tournament is USBC certified and all USBC rules apply with the exception of rule 319a2, 319d, and 319e.
- 5. Failure to use the proper average shall DISQUALIFY score if the submitted average is lower than the actual average thereby resulting in a higher handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average (rule 319a-3).
- 6. **Early Bird Entry Fee is \$18.00** (\$10.00 fees and expenses and \$8.00 prize fund). Prize fund will be returned 100%. One in every 5 entries will cash.
- 7. Please submit applications together if you have a group that you would like to bowl with or write the names on the bottom or the back of this entry form. We will do our best to accommodate all requests.
- 8. Reserved entries close October 24, 2018. We will accept walk-ins on October 27, 2018. On-site entry for this event is \$23.00 providing lanes are available. The additional cost of entry will be added to the prize fund.
