Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. If a bowler earns \$600 or more for the entire 90th Greater Lake County USBC Championships, the member's Social Security number must be provided to the Greater Lake County USBC before their check will be issued.

- Eligibility: All participants must be members of the Greater Lake County USBC for the current season with a minimum of 15 games by December 8, 2018, or have a minimum of 21 games in the 2017-2018 season in one Greater Lake County USBC league.
- 2. Greater Lake County USBC and past LCBA, LCWBA and WWBA Hall of Fame members are exempt from rule 1.
- 3. All scores are scratch.
- 4. **Practice session:** All assigned lanes will be allowed to be bowled on before the qualifying round.
- 5. **Early-bird entry:** Prize fee shall be \$47.00 per bowler per event. Bowling and expense fees shall be \$18.00 per bowler. (*) On-site entry fee is \$5.00 additional per bowler. The additional fee will be added to the prize fund.
- 6. The Prize fund will pay out 100% with a 1 in 5 ratio.
- 7. Scores recorded by official scorekeeper or automatic scoring will be final.
- 8. Assignment of lanes will be blind drawn or assigned by the Tournament Committee.
- 9. All decisions of the tournament committee are final.
- 10. There will be a \$25.00 charge for NSF checks
- 11. Distribution of the prize money will be made in accordance with USBC tournament rules.

Event Format

Check-in time 11:00 AM
Practice starts at 12:00 Noon.
First Round is a 5-game qualifier.

The field will be cut in half rounding up to an even number of bowlers based on total pinfall.

Each round one additional game will be bowled eliminating half the field based on total pinfall until the event is down to four bowlers bowling a final game. Final standing is based on pinfall.

Note: The entrants whose name appears heron agree that the Greater Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater Lake County USBC.
