90th Open Championships Greater Lake County USBC Tournament Rules

Please read carefully!

Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. If a bowler earns \$600 or more for the entire 90th Greater Lake County USBC Championships, the member's Social Security number must be provided to the Greater Lake County USBC before their check will be issued.

1. **Eligibility:** All participants must be members of the Greater Lake County USBC for the current season with a minimum of 18 games by the end of February 3, 2019 or have a minimum of 21 games in the 2017-2018 season in one Greater Lake County USBC league.
2. This tournament will be conducted in strict accordance with the Constitution Rules and regulation of the USBC and the Greater Lake County USBC.
3. Entrants will use their highest USBC certified league final (book) average based on a minimum of 21 games for the 2017-2018 season. Any entrants not having a 2017-2018 season average will use their highest 2018-2019 season certified USBC league average as of the entrant's first scheduled bowling event; you must have at least 12 games. If the entrant does not have either a 2017-2018 book average or a qualifying current average, a 2017 summer league final average (based on a minimum of 21 games) will be accepted with appropriate verification. An entrant arriving at the tournament without appropriate verification of a summer league average or a current 2018-2019 season average will bowl scratch. If an entrant does not have an average meeting the set forth criteria, he/she will bowl scratch.
4. All games bowled will be given 90% handicap, based on: team average of 220 for Singles and All-Events, 440 for Doubles Event and 1,100 for team event.
5. Greater Lake County USBC and past LCBA, LCWBA and WWBA Hall of Fame members are exempt from rule 1.
6. Entrant having 10 pins or more higher than the previous season's average, as of February 3, 2019, bowler must use their highest current USBC league average.
7. Individual entries for Single or Doubles events will not be accepted. One must enter both events, viz., Doubles and Singles.
8. **Early-Bird entry:** Prize fee shall be \$14.25 per bowler per event. Bowling and expense fees shall be \$10.75 per bowler/per event for. (*)**On-Site entry** fee is \$5.00 additional per bowler, per event. The additional fee will be added to the respective events prize fund.
9. All prior reservation must be paid in full by February 3, 2019 by 6:00 P.M. After that time all unpaid entry reservations will be released. NO EXCEPTIONS!
10. Any entrant that participates in Team, Doubles and Singles events will automatically be entered into the All-Events prize list. Two dollars from each entry from each event will be put into the All Events prize fund. All Events will pay minimum one winner out of each 12 entries in the handicap division.
11. Cash prizes in the Team, Doubles and Singles will be awarded on a handicap basis with a minimum of one winner out of each eight (8) entries on each event.
12. Assignment of lanes will be pre-drawn by the Tournament Committee.
13. Practice bowling on each starting pair of lanes only prior to Team and Doubles events only. Doubles will be bowled first, Singles will be bowled second. Team event will have ten(10) minutes of practice. Doubles & Singles will have six(6) minutes of practice.
14. Championship awards and cash prizes will be presented in Team, Doubles, Singles and All Events for the highest scores with handicap. Suitable awards will be presented to the actual champions in the Team, Doubles, Singles and All Events for scratch scores. Separate cash prizes are based on the participation in the optional scratch events. In case of a tie in any event, all tied participants will receive identical suitable awards. In addition, all champions will receive Suitable awards.
15. Optional Scratch division events are an additional \$5.00 per person/per event. Optional Scratch divisions will pay (1) one winner out of each ten (10) entries. Optional Scratch Team and Doubles participants must bowl together as a team on the same lanes in each event. NO EXCEPTIONS! Optional Scratch Division entries will be available prior to the start of each participant's event. Participants wanting to participate in the Optional Scratch All Events MUST purchase entry prior to beginning of the first team event. Individual Optional scratch All Events total will use first team event score.
16. Scores recorded by official scorekeeper or automatic scoring will be final.
17. Entrants may bowl in the five-bowler Team event as a member of more than one regularly organized team under the following rules:
 - a. Only three (3) members of a five-bowler team already entered in this tournament may bowl together on another five-bowler team.
 - b. No more than two (2) PBA members are allowed on the roster in the team event. No more than one (1) PBA member is allowed in the Doubles Event.
 - c. Bowlers who are entered more than once in the five-bowler event must have participated in at least 18 regular schedule games from each league from which they are entered as of February 4, 2018. A bowler may bowl on one additional team up to the number of certified Greater Lake County USBC leagues the bowler is participating in for the 2017-2018 winter season with a minimum of 18 games by February 3, 2019.
 - d. When a bowler is a member of two or more five-bowler teams entered in the Greater Lake County USBC tournament, their first score bowled in the five-bowler Team event shall count towards their All Events score.
 - e. A bowler may only enter and participate in the Doubles and Singles events once.
18. Distribution of the team prize money and awards shall be the team captain's responsibility.
19. Penalty for violations of any portion of the above rules shall be forfeiture of all fees paid and disqualified from the tournament.
20. Team captain shall be held responsible for any and all tournament rules violations.
21. All entries must be accompanied by an entry for with at least a Team or Doubles and Singles roster filled before any shots are thrown.
22. All decisions of the tournament committee are final.

Note: The entrants who names appear hereon or their replacements hereby agree that the Greater Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies of causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater Lake County USBC.
