## Rules

Eligibility – Greater Lake County USBC Baker Team tournament is open to all members of the GLCUSBC who have a 2017-18 GLCUSBC average with a minimum of 21 games bowled or have a current 2018-19 GLCUSBC average with at least 15 games bowled. The highest 2017-18 USBC average will be used for this tournament. All participants must be members of the GLCUSBC for the 2018-19 season. If a bowler meets the above requirements, he/she may purchase membership at the tournament.

*Entry Fee* – The early bird entry fee is \$150.00 per team (\$50 Lineage and expenses, \$100 prize fund). On-site entry for this event is \$175.00; the additional \$25.00 fee will be added to the events prize fund. The prize fund will be returned 100%. Prize ratio 1:5 minimum.

*Handicap* – Handicap will be 1/5 of 90% of the difference of the team average and 1,100 per game. No negative handicap will be used. *No team average limit*.

*Format* – All teams will bowl 15 Baker games during qualifying. Teams will receive 30 bonus points for wins, 15 bonus points for ties and zero points for a loss. All scores are total pin fall with handicap plus bonus pins.

The 16<sup>th</sup> game is a position round cutting to the top four teams based on total pin fall plus handicap and bonus points (if 20 or more teams, the top 6 teams) will advance to a match play finals. Match play will consist of a single game round robin match with a final position round game.

The team with the highest total (pin fall with handicap plus bonuses) will have lane choice in all match play games. The team on the left lane will start all games in both qualifying and match play. The team with highest pin fall, handicap and bonus pins total in qualifying and all match play games will be declared champions.

In the case of a tie for final advancing position for match play, a one-game (total pin fall plus handicap) roll off will determine who advances to match play. A tie for first position after all match play, a one-game roll off (total pin fall plus handicap), and the highest total will be declared champion. Any ties in cashing positions other than first will be combined and split evenly. Teams must use the same five bowlers for all games bowled. Teams may change line up after any game.
