91st Open Championships Greater Lake County USBC Tournament Rules

Please read carefully!

Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. If a bowler earns \$600 or more for the entire 91st Greater Lake County USBC Championships, the member's Social Security number must be provided to the Greater Lake County USBC before their check will be issued.

- 1. **Eligibility:** All members of the Greater Lake County USBC are eligible to enter. USBC members who are eligible for another association championship tournament must bowl a minimum of 18 games by the end of January 12, 2020 or have a minimum of 21 games in the 2018-2019 season in one Greater Lake County USBC league.
- 2. This tournament will be conducted in strict accordance with the Constitution Rules and regulation of the USBC and the Greater Lake County USBC.
- 3. Bowlers with less than 21 games during the 2018-2019 season will be required to use their highest established average from the prior three seasons. Absent of an average from the previous three season's bowler will bowl scratch. New USBC members with a minimum of 21 games can use their 2019-2020 average with verification. All games bowled will be given 90% handicap, based on team average of 220 for Singles and All-Events, 440 for Doubles Event and 1,100 for the team event
- 4. Greater Lake County USBC and past LCBA, LCWBA and WWBA Hall of Fame members are exempt from rule 1.
- 5. Entrant having an average 10 pins higher than the previous season's average, as of January 18, 2020, the bowler must use their highest current USBC league average.
- 6. Individual entries for Single or Doubles events will not be accepted. One must enter both events, viz., Doubles and Singles.
- 7. **Early-bird entry:** Prize fee shall be \$14.25 per bowler per event. Bowling and expense fees shall be \$10.75 per bowler/per event. **(*) On-site entry** fee is \$5.00 additional per bowler, per event. The additional fee will be added to the respective events prize fund.
- 8. All prior reservations must be paid in full by January 12, 2020, by 6:00 P.M. After that time all unpaid entry reservations will be released. NO EXCEPTIONS!
- 9. Any entrant that participates in Team, Doubles and Singles events will automatically be entered into the All-Events prize list. Two dollars from each event will be put into the All Events prize fund. All Events will pay a minimum of one winner out of each 12 entries in the handicap division.
- 10. Cash prizes in the Team, Doubles, and Singles events will be awarded on a handicap basis with a minimum of 1:5 entries in each event.
- 11. The assignment of lanes will be pre-drawn by the Tournament Committee.
- 12. Practice bowling on each starting pair of lanes only before Team and Doubles events only. Doubles will be bowled first, Singles will be bowled second. The team event will have ten (10) minutes of practice. Doubles & Singles will have six (6) minutes of practice.
- 13. Championship awards and cash prizes will be presented in Team, Doubles, Singles and All Events for the highest scores with handicap. Suitable awards will be presented to the actual champions in the Team, Doubles, Singles and All Events for scratch scores. Separate cash prizes are based on the participation in the optional scratch events. In case of a tie in any event, all tied participants will receive identical suitable awards. In addition, all champions will receive Suitable awards.
- 14. Optional Scratch division events are an additional \$5.00 per person/per event. Optional Scratch divisions will pay (1) one winner out of each ten (10) entries. Optional Scratch Team and Doubles participants must bowl together as a team on the same lanes in each event. NO EXCEPTIONS! Optional Scratch Division entries will be available before the start of each participant's event. Participants wanting to participate in the Optional Scratch All Events MUST purchase entry before the beginning of the first team event. Individual Optional scratch All Events total will use the first team event score.
- 15. Scores recorded by official scorekeeper or automatic scoring will be final.
- l.6. Entrants may bowl in the five-bowler Team event as a member of more than one regularly organized team under the following rules:
 - a. Only three (3) members of a five-bowler team already entered in this tournament may bowl together on another five-bowler team.
 - b. No more than two (2) PBA members are allowed on the roster in the team event. No more than one (1) PBA member is allowed in the Doubles Event.
 - c. Bowlers who are entered more than once in the five-bowler event must have participated in at least 18 regular schedule games from each league from which they are entered as of January 18, 2020. A bowler may bowl on one additional team up to the number of certified Greater Lake County USBC leagues the bowler is participating in for the 2018-2019 winter season with a minimum of 18 games by January 18, 2020.
 - d. When a bowler is a member of two or more five-bowler teams entered in the Greater Lake County USBC tournament, their first score bowled in the five-bowler Team event shall count towards their All Events score.
 - e. A bowler may only enter and participate in the Doubles and Singles events once.
- 17. Distribution of the team prize money and awards shall be the team captain's responsibility.
- 18. Penalty for violations of any portion of the above rules shall be forfeiture of all fees paid and disqualified from the tournament.
- 19. The team captain shall be held responsible for all tournament rules violations.
- 20. All entries must be accompanied by an entry for with at least a Team or Doubles and Singles roster filled before any shots are thrown.
- 21. All decisions of the tournament committee are final.

Note: The entrants whose names appear hereon or their replacements hereby agree that the Greater Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies of causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater Lake County USBC.
