All GLCUSBC events are subject to the Restore Illinois 5 Phase plan guidelines. The host center and/or the tournament director might have to revise event rules to accommodate the mandated changes.

TOURNAMENT RULES

This event is certified with the United States Bowling Congress and USBC tournament rules apply.

Participation

Due to Covid, the GLCUSBC offers a three-year membership eligibility for participation in association events. Participation will require GLCUSBC membership during the 2021-2022 season along with participating in an active league.

Individuals who are members of bowling organizations, identified as “professional,” are eligible for participation; however, not more than one professional bowler may compete on a four-member or two-member team.

The tournament will consist of Mixed Team Event (2 males and 2 females) and Mixed Doubles Event (1 male and 1 female).

Entrants may bowl as often as they wish but can only cash once with more than two of the same members on the team or with the same partner (Rule #315). Re-entries for previous entrants will be allowed subject to lane availability.

Averages

This is a standard average event. Bowlers will use their highest 2020-2021 standard league average. Absent a standard average, the bowler will use his/her highest Challenge or Sport Converted average.

If the bowler does not have a 2020-2021 average, the highest average from the previous three seasons with a minimum of 21 games will be used. All others must bowl scratch.

Misrepresentation of Averages - (Rule 319a3) Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain, or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler’s score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. Rules 319a2. 319d. and 319e are waived during this event.

Handicap - 90% of 220 – All averages will be verified at bowl.com

Scoring and Practice - No blind/vacant score will be allowed in the tournament. Lanes will be turned on for ten (10) minutes of practice. Absent or late bowlers will receive zero (0) pins for each frame missed.

Prize Fund - Prize money is returned 100%.

A prize list will pay at least 1:5 in each of these following classifications:

- Team Event
- Singles Event

Recognition payouts for the following classifications:

- High Game – Handicap and Scratch
- High Series – Handicap and Scratch

Early Bird Entry Fee - Entries open OCTOBER 18, 2021. Please reserve and pay for your squad date by November 6, 2021. Entry fee is \$30.00 per bowler, per event.

On-site entry is \$35 per bowler/per event and the additional fee will be added to the prize fund. Walk-in entry is required one hour prior to squad start time and subject to lane availability.

Entries close on the last squad Sunday, November 21, 2021, at 4:30 PM subject to lane availability.
