93rd Open Championships Greater Lake County USBC Tournament Rules

Please read carefully!

Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. If a bowler earns \$600 or more for the entire 93rd Greater Lake County USBC Championships, the member's social security number must be provided to the Greater Lake County USBC before the check will be issued.

1. **Eligibility:** GLCUSBC members, with at least 21 games recorded in one league during the 2020-2021 season, are eligible to bowl with proof of membership for the 2021-2022 season. All members of the GLCUSBC, effective with the 2021-2022 season, will be required to have a 21-game certified average in a GLCUSBC league by the event's start date.
2. Greater Lake County USBC and past LCBA, LCWBA and WWBA Hall of Fame members are exempt from Rule 1.
3. **Averages:** This is a standard average event. Bowlers will use their highest 2020-2021 standard league average. Absent a standard average, the bowler will use their his/her Challenge or Sport Converted average. All averages are based on a minimum of 21 games. Entrants having an average 10 pins higher than the previous season's average, as of March 5, 2022, must use their highest current USBC league average.
4. All current GLCUSBC members are eligible for one team entry. Additional Team event participation will be subject to the number of certified leagues with a minimum of 21 games as recorded during the 2021-2022 season.
5. Handicap is based on a 90% of a 220 average for Singles and All-Events, 440 for Doubles event and 1,100 for the Team event.
6. Individual entries for Single or Doubles events will not be accepted. One must enter both events, e.g., Doubles and Singles.
7. **Early-bird entry:** Prize fee shall be \$13 per bowler/per event. Bowling and expense fees shall be \$12 per bowler/per event. **(*) On-site entry fee is \$5 additional per bowler/per event.** The additional fee will be added to the respective event's prize fund.
8. All prior reservations must be paid in full by February 27, 2022 by 6:00 p.m. After that time, all unpaid entry reservations will be released. NO EXCEPTIONS!
9. Cash prizes in the Team, Doubles, and Singles events will be awarded on a handicap basis with a minimum of 1:5 entries in each event.
10. The assignment of lanes will be pre-drawn by the Tournament Committee.
11. Practice bowling on each starting pair of lanes only before Team and Doubles events only. The team event will have ten (10) minutes of practice. Doubles & Singles will have six (6) minutes of practice. The Doubles event will be bowled first, Singles second.
12. Championship awards and cash prizes will be presented in Team, Doubles, Singles and All Events for the highest scores with handicap. Suitable awards will be presented to the actual champions in the Team, Doubles, Singles and All Events for scratch scores. Separate cash prizes are based on the participation in the optional scratch and handicap events. In case of a tie in any event, all tied participants will receive identical suitable awards. In addition, all champions will receive suitable awards.
13. Optional Handicap and Scratch division events are an additional \$5 per person/per event. All Events will pay a minimum of 1:5 entries. Optional Scratch divisions will pay 1:10 entries. Optional Scratch Team and Doubles participants must enter these events as a team. NO EXCEPTIONS! ONLY FULLY PREPAID ENTRIES ARE ELIGIBLE FOR OPTIONAL EVENTS.
14. Scores recorded by official scorekeeper or automatic scoring will be final.
15. Entrants may bowl in the five-bowler Team event as a member of more than one regularly organized team under the following rules:
 - a. Only three (3) members of a five-bowler team already entered in this tournament may bowl together on another five-bowler team.
 - b. No more than two (2) PBA members are allowed on the roster in the team event. No more than one (1) PBA member is allowed in the Doubles Event.
 - c. When a bowler is a member of two or more five-bowler teams entered in the Greater Lake County USBC tournament, his/her first score bowled in the five-bowler Team event shall count towards the All Events score.
 - d. A bowler may only enter and participate in the Doubles and Singles events once.
16. Distribution of the team prize money and awards shall be the team captain's responsibility.
17. Penalty for violations of any portion of the above rules shall be forfeiture of all fees paid and disqualified from the tournament.
18. The team captain shall be held responsible for all tournament rule violations.
19. All entries must be submitted with an entry form with at least a Team or Doubles and Singles roster filled before any shots are thrown.
20. This tournament will be conducted in strict accordance with the Constitution Rules and regulation of the USBC and the Greater Lake County USBC.
21. All decisions of the tournament committee are final.

Event rules are subject to change by the host center and/or tournament director based on any Local, State, or National COVID mandate changes.

Note: The entrants whose names appear hereon or their replacements hereby agree that the Greater Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies of causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater Lake County USBC.

All averages will be verified before any prizes are awarded.
