Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. If a bowler earns \$600 or more in this event, the Social Security number must be provided to the Greater Lake County USBC before the check will be issued.

1. **Eligibility:** GLCUSBC members, with at least 21 games recorded in one league during the 2020-2021 season, are eligible to bowl with proof of membership for the 2021-2022 season. All members of the GLCUSBC, effective with the 2021-2022 season, will be required to have a 21-game certified average in a GLCUSBC league by the event's start date.
2. Greater Lake County USBC and past LCBA, LCWBA, and WWBA Hall of Fame members are exempt from Rule 1.
3. **All scores are scratch.**
4. **Practice session:** All assigned lanes will be allowed to be bowled on before the qualifying round.
5. **Early-bird entry:** The prize fee shall be **\$40** per bowler, per event. Bowling and expense fees shall be **\$25** per bowler. **(*) The On-site entry** fee is **\$5** additional per bowler. The additional fee will be added to the event prize fund.
6. The prize fund will pay out 100% with a 1 in 5 ratio.
7. Scores recorded by the official scorekeeper or automatic scoring will be final.
8. Assignment of lanes will be blind drawn or assigned by the Tournament Director.
9. All decisions of the tournament committee are final.
10. There will be a \$25.00 charge for NSF checks.
11. Distribution of the prize fund will be made in accordance with USBC tournament rules.

Event rules are subject to change by the host center and/or tournament director based on any Local, State, or National COVID mandate changes.

Event Format

Check-in time 12:00 Noon

Practice starts at 1:00 P.M.

- First Round is a 4-game qualifier.
- Rounds 2-5 the top 16 bowlers will advance to match play, 1 vs 16, 2 vs 15, 3 vs 14, etc.
- Single-game match play will eliminate half the field until a champion is decided.

Note: The entrant whose name appears hereon agrees that the Greater Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule changes, or premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater Lake County USBC.
