2024 Women's Championship Tournament Rules	
1.	All entrants must be members of the Greater Lake County USBC, currently bowling in a GLCUSBC certified league, and be at least 18 years of age.
2.	Teams should be checked in by the team captain at least 30 minutes before scheduled to bowl. The Tournament Manager will assign all lanes. Teams desiring to cross lanes must submit entries in the same envelope. Each individual shall be responsible for verifying her entering average.
3.	Members are allowed to bowl more than once in any Event, however; no more than three bowlers on one team can place more than once in prize list. In Doubles Event, a bowler may cash only once with the same partner, and in Singles Event a bowler may only cash once with her highest score. Entrants in the Doubles Event must also enter the Singles Event and vice versa.
4.	Doubles and Singles events are one squad and may not be bowled at different times. No more than three sets of Doubles teams will be assigned to a pair of lanes.
5.	A first place title will be recognized and awards will be given for the highest Handicap and Scratch scores including All Events. Only members who enter the \$5.00 optional Handicap All Events can cash from that prize fund. Only members who enter the \$5.00 optional Scratch Division Events can cash from those prize funds. Cost for the Optional Scratch Division events is \$5.00 per bowler/per event including Team, Doubles, Singles and All Events. These optional fees must be paid prior to bowling your first event. Please note bowlers may not enter Team and Doubles Scratch Events individually.
6.	Bowling shall begin in accordance with a previously arranged schedule. Any player or team arriving late shall begin play and the score shall count beginning with the current frame being bowled. Prior frames will be scored at zero.
7.	Substitutes are allowed when a replacement is necessary. The Tournament Manager must be notified at least one hour before the scheduled bowling time. In case of any emergency, if a game has started, a substitute shall be allowed on the team and/or doubles event. Once a substitute starts she must finish the series, unless physically unable.
8.	A substitute shall not be required to reimburse the entry fee paid nor give the original entrant any prize money or awards won.
9.	Scores are not final until they have been audited.
10.	Any protest affecting eligibility or general playing rules must be confirmed in writing to the Tournament Manager before the tournament prize payments are made. Errors in scoring must be reported to the Tournament Manager within 24 hours.
11.	The ENTRY fee is \$30 per bowler/per event for entries paid by January 20th. Entry fees will not be returned once squad begins. Association is not responsible for cash sent through the mail. Walk-in entries accepted until one hour prior to squad time, subject to lane availability.
12.	Only scorekeepers and bowlers are allowed in settee area. No food or beverages will be allowed on lanes or in bowlers' area.
13.	Handicap will be 90% of 230 and is calculated as the difference of your highest USBC certified league average from 2022-2023 season and 230 scratch.
14.	All entrants in this tournament shall use their highest standard USBC certified league final average from the 2022-2023 season, with a minimum of 21 games. If no final average from 2022-2023, entrants shall use their highest standard USBC certified average for 21 games or more as of and including January 26, 2024. USBC certified 2022-2023 youth or collegiate league averages with a minimum of 21 games will be accepted providing there is verification. All others will bowl scratch.
15.	Prize fee will be returned 100% on handicap scores, at least 1:5 entries will cash. Optional Handicap All Events and Scratch division events will pay 1:10 entries. Prize fund may be increased by on-site entry fees and/or donations.
16.	Failure to comply with the tournament rules may be cause for disqualification.
17.	The Board of the Greater Lake County USBC will decide any questions not covered by the tournament rules. The Tournament Manager has the right to rerate a bowler's average (USBC Rule 319c). Rule 319a-2 does not apply.
18.	This is a President's Cup qualifier in which you must bowl All Events to be eligible. Individual performance in this event is also given consideration for Bowler of the Year honors.
19.	Any tournament official has the right to disqualify a bowler who engages in improper conduct in connection with the game of bowling including, but not limited to, verbal abuse.
