TOURNAMENT RULES

Participation: A bowler must have a GLCUSBC membership during the 2023-2024 season along with participation in an active league. Individuals who are members of bowling organizations, identified as "professional," are eligible for participation; however, not more than one professional bowler may compete on a four-member or two-member team. The tournament will consist of Mixed Team Event (two males and two females) and Mixed Doubles Event (one male and one female). Entrants may bowl as often as they wish but can only cash once with more than two of the same members on the team or with the same partner (Rule #315). Re-entries for previous entrants will be allowed subject to lane availability.

Average: This is a standard average event. Bowlers will use their highest 2022-2023 standard league average based on 21 games or more. Absent a standard average, the bowler will use his/her highest Challenge or Sport converted average. If there is no final average from 2022-2023, entrants shall use their highest USBC 2023-2024 GLCUSBC certified average for 12 games or more as of the date of participation in the tournament, in which case a league standing sheet must be provided to the tournament director. All others will bowl scratch.

Misrepresentation of Averages - (Rule 319a3) Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler's score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average. In the case of a team of two or more bowlers, the averages will be combined to determine if the correct total is higher or lower than the submitted total. Rules 319a2, 319d and 319e are waived for this event.

Handicap: 90% of 220 – All averages will be verified at bowl.com

Scoring and Practice: No vacant scores will be allowed in the tournament. Lanes will be turned on for ten (10) minutes of practice. Absent or late bowlers will receive zero (0) pins for each frame missed.

Prize Fund: Prize money is returned 100%. The prize list will pay at least 1:5 for both team and doubles event.

Early-bird entry: Opens **October 1, 2023**. Please reserve and pay for your squad date by **October 28, 2023**. **Entry fee is \$30 per bowler/per event**. On-site entry is **\$35** per bowler/per event. The additional fee will be added to the prize fund. Walk-in entry is available one hour prior to squad time subject to lane availability. Entries close **Sunday, November 12, 2023** at 3:30 PM subject to lane availability.
