9-PIN NO-TAP TOURNAMENT RULES

All entrants must be current certified members of the Greater Lake County USBC and bowling in a GLCUSBC league in a certified center. Age division for entry is subject to the bowler's current age as of January 20, 2024. All entrants 49 and under will bowl in the REGULAR division and bowlers 50-69 in the SENIOR division based on gender. All bowlers 70 and greater will bowl in the SUPER SENIOR division. Entrants may bowl multiple squads but can only cash once in this event.

Entrants in this tournament shall use their highest USBC certified final average from the 2022-2023 season (minimum of 21 games). If there is no final average from 2022-2023, entrants shall use their highest USBC certified average for 21 games or more as of January 19, 2024, in which case a league standing sheet must be provided to the tournament director. All others will bowl scratch. This is a standard average tournament, but if his/her average is from a Sport or Challenge league, it will be converted.

Format for the tournament is a three-game, 9-pin no-tap handicap event. The handicap for ALL bowlers, ages 69 and under, will be 90% of 220. The handicap for bowlers, ages 70 and over, will be 100% of 220.

This tournament is USBC certified and all USBC rules apply except for Rules 319a2, 319d, and 319e.

Failure to use the proper average shall disqualify all scores if the submitted average is lower than the actual average thereby resulting in a higher handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average (Rule 319a3).

Early-bird entry fee is \$30.00. (\$13.00 expenses and \$17 for the prize fund). The prize fund will be returned 100% with a payout ratio of at least 1:5.

Please submit all applications at one time if you have a group that would like to bowl together or list their names on this entry form.

Reserved entries close January 16, 2024. We will accept walk-ins until 30 minutes prior to squad start times *subject to lane availability*. On-site entry/late fee is an additional \$5.00. Late fee will be added to the prize fund.
