Tournament Rules

1. GLCUSBC youth bowler will use his/her highest 2019-20 league average. If none, then use the current league average. (Send a copy of the standing sheet by March 14, 2021 along with entry form.) If youth bowler does not have a 2019-20 average and does not provide a league standing sheet, he/she will bowl scratch.
2. Adults do not have to be sanctioned to bowl in this event. Adults will be given a score of 200 per game/600 per series. All pins bowled over 600 series will be added to the final score. Youth Handicap: 90% of 210.
3. Coaching will be allowed by coaches/parents. The bowler must approach the coach/parent on his/her own. Under no circumstances can a coach/parent enter the bowling area or solicit the bowler to come to them.
4. DRESS CODE: A collared or league-style shirt is preferred along with dress pants or slacks. Girls may wear skorts or shorts but they must reach the tip of their fingertips. ABSOLUTELY NO hats, electronic listening devices, cell phones, smartwatches, clothing or equipment depicting tobacco, alcohol or negative material will be allowed. The tournament committee has the final decision on appropriate attire. **MASKS will be required by all bowlers and spectators.**
5. ENTRY DEADLINE: Entry fee is \$30 per team. (Entry includes \$18 for lineage—\$12 for awards.) Entries must be postmarked by March 14, 2021. **Entries are limited to 36 – due to covid restrictions.**
6. Prizes will be awarded in each division. Winnings will be provided through SMART Fund scholarships.
7. COVID Disclaimer: Event rules are subject to change by the host center and/or tournament director based on any Local, State, or National COVID mandate changes.
