	2021 Women's Championship Tournament Rules						
1 All entrants must be members of the Greater Lake County USBC and be at least 18 years of age.							
2	Teams shall be checked in by the captain at least one-half hour before the team is scheduled to bowl. The Tournament Manager will assign all lanes. Teams desiring to cross lanes must submit entries in						
	the same envelope. Each individual shall be responsible for verifying her average in all leagues.						
3	Members are allowed to bowl more than once in any event; however, no more than three bowlers on						
	one team can place more than once in prize list. In doubles event, a bowler may cash only once with						
	the same partner, and in singles event a bowler may only cash once with the highest score. Entrants in						
	the doubles event must also enter the singles event and vice versa.						
4	Doubles and singles are a one-squad event and may not be bowled at different times. No more than three sets of doubles teams will be assigned to a pair of lanes.						
5	All-Events: A first-place title will be recognized for Handicap and Scratch All Events total. Only						
	members who enter the \$2 Optional All Events can cash from the optional Handicap All Events prize						
	fund. Only members who enter the \$5 Scratch All Events can cash from the optional Scratch All Events						
	prize fund.						
6	Blind scores are not allowed in the tournament. Bowling shall begin in accordance with a previously						
	arranged schedule. Any player or team arriving late shall begin play and the score shall count beginning with the current frame being bowled.						
7	Substitutes are allowed when a replacement is necessary. The secretary must be notified at least one						
'	hour before the scheduled bowling time. In case of any emergency, if a game has started, a substitute						
	shall be allowed on the team and/or doubles event. Once a substitute starts a series, the substitute						
	must finish it, unless physically unable. Any ICE substitutes will not bowl in singles.						
8	A substitute shall not be required to reimburse the entry fee paid nor give the original entrant any						
9	prize money or trophy won. Scores recorded by official scorekeepers are not final until they have been audited.						
10	Any protest affecting eligibility or general playing rules must be confirmed in writing to the						
	Tournament Secretary before the tournament prize payments are made. Errors in scoring must be						
	reported to the Tournament Secretary within 24 hours.						
11	The ENTRY fee is \$25 per bowler, per event for entries paid. Entry fees will not be returned once the						
	tournament is scheduled. Association is not responsible for cash sent through the mail. NSF check						
12	charge will be \$25. Only scorekeepers and bowlers are allowed in settee area. No food or beverages will be allowed on						
12	lanes and bowlers' area.						
13	Handicap will be 90% of 220 and is calculated as the difference of your highest USBC certified league						
	average from 2019-2020 season and 220 scratch.						
14	All entrants in the GLCUSBC tournament shall use their highest USBC certified league final						
	average from the 2019-2020 season, with a minimum of 21 games. If no final average from						
	2019-2020, entrants shall use their highest USBC certified average for 21 games or more as of						
	and including May 1, 2021. If the bowler is not bowling in a current league, and Tournament Manager can't confirm an entrant's average on bowl.com, the entrant will bowl scratch.						
15	Prizes - 100% prize fee will be paid on handicap scores and one of every five entries will cash. Prize						
	fund may be increased by on-site entry fees and or donations.						
16	Awards will be given for the highest handicap and scratch scores. Individual awards will be given to						
	handicap and scratch championship teams. In case of a first-place tie in ANY event, CO-CHAMPIONS						
	will be declared and awards given. There will be a scratch division, costing \$5.00 per bowler/per event. This must be paid with the entry fees.						
17	Failure to comply with the tournament rules may be cause for disqualification.						
18	The Board of the Greater Lake County USBC Bowling Association will decide any questions not						
	covered by the tournament rules. The Tournament Manager has the right to rerate a bowler's						
	average. (USBC Rule 319c) Rule 319a-2 does not apply.						
19	USBC certified youth or collegiate league averages will be accepted providing there is verification.						
20	Any tournament official has the right to disqualify a bowler who engages in improper conduct in connection with the game of bowling including, but not limited to, verbal abuse.						
21	Note: The entrants whose names appear hereon or their replacements hereby agree that the Greater						
-1	Lake County USBC, its officers and agents shall be liable only to the extent of returning entry fees if						
	and when these entrants shall be prevented from bowling any event in the tournament through delay,						
	unexpected yet necessary schedule changes, or premature termination of the tournament, which may						
	be brought about by war, national emergency or emergencies of causes relating thereto or resulting						
	therefrom fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Greater						
	Lake County USBC. This includes the COVID-19 virus.
