## 2022 Pins Over Average Tournament Rules

- 1. All entrants must be current, active members of the Greater Lake County USBC.
- 2. Bowlers will use their highest 2021-2022 standard league average. All new GLCUSBC members will be required to have a 21 game certified average by April 8, 2022.

A current league standing sheet will be required for all bowlers.

- 3. Format for both divisions: All entrants will bowl 4 games across 8 lanes. Top 16 (or half of the field, if less than 32 bowlers) will advance to the 2nd round. In the 2nd round all bowlers will bowl 2 games across 4 lanes with the top 5 advancing (based on the number of entrants) to the stepladder finals. *Pins will not carry over*; each round starts at (0) zero. In case of a tie in the stepladder finals, a 9th & 10<sup>th</sup> frame roll off will take place.
- 4. The tournament is USBC certified and all rules apply. All decisions by the tournament director are final.
- 5. Prize fund will pay out 100%. Payout ratio is at least 1:5.
- 6. NSF check fee is \$25.
- 7. Entry fee is \$40 for entries paid by April 8, 2022. Walks-ins will be accepted based on lane availability until 12 p.m. On-site fee is \$45. The additional money will be added to the prize fund.
- 8. Event rules are subject to change by the host center and/or tournament director based on any Local, State, or National COVID mandate changes.
